Candidate questionnaire

Candidates wishing to stand for election must submit a Nomination Form via the online portal.

You are required to:

- Write a 300 word 'Platform Statement' (which will be published for Voting Members)
- Answer eight questions
- Provide a copy of your CV

The final two elements will be used to assist in the transition process and to assist in preparing for the role. These answers will not be shared with members.

Extracted below are the questions you will be asked during the nomination process.

In addition, you will also need two Avant Voting Members to endorse your nomination (providing their name, contact details and member number when completing the nomination form online).

Only the Platform Statement will be made available to Voting Members.

Additional Information supporting your candidacy – key criteria (not for publication)

1. Previous involvement with Avant

Please provide details of any past involvement you have had with Avant. This may include sitting on a member committee (e.g. Medical Experts Committee/Advisory Committee) or as a Medical Expert. (maximum 250 words)

2. Governance experience

Please provide details of any relevant governance experience you may have had. For example, other boards you have been appointed to or committees you have contributed to. (Please include details of entities which you believe may be most relevant to Avant.) (maximum 250 words)

3. Medical indemnity experience

Please provide details of any medico-legal experience you have. This might include any medical expert or quality/safety governance roles you may have had. (maximum 250 words)

4. Medical leadership

Please provide details of any leadership roles you have played within the medical community, or at your place of practice. (maximum 250 words)

5. Other relevant staff leadership experience

Please provide details of any other leadership experience you have (this may include in a non-medical context). This is primarily referring to experience motivating people to perform at their best. (maximum 250 words)

6. Strategic planning experience

Please provide details of any strategic planning work you have previously been involved in, in any capacity. If you have any such experience please provide those details here. Please include any particular successes that arose from this work. (maximum 250 words)

7. Commercial experience

Experience running or leading a business (any size or shape). If you have any such experience please provide details here, and call out any major successes. (maximum 250 words)

Additional Information supporting your candidacy – key criteria cont'd (not for publication)

8. Financial services or insurance experience

Experience in general insurance, private health insurance or life insurance would be beneficial given the nature of the expectations of Avant's regulators. If you have such experience, please provide details. (maximum 250 words)

9. Curriculum Vitae

Please upload your CV.

10. Supporting Statement

Having answered the eight questions, please provide a statement (to be published for Voting Members), summarising your responses, focusing on how you meet the Key Criteria, and how you have demonstrated your commitment to Avant. (maximum 300 words)
